**TUITION AND FEE SCHEDULE**

**REGISTRATION & APPLICATION FEE (Non-Refundable/Non-Transferable)**

\$375.00 per student will be charged annually and is payable at the time of registration.

**SCHOOL IMPROVEMENT FEE (Non-Refundable/Non-Transferable)**

\$350.00 per family is due during enrollment, at the time of payment plan set-up.

**TESTING FEE (Non-Refundable/Non-Transferable)**

\$75.00 entrance exam fee for new students entering K5 – 5<sup>th</sup> grade is due on the day of testing.

\$50.00 school observation fee for new students entering K2 – K4 is due on the day of observation.

**FACTS ENROLLMENT FEE (for setting up tuition payments)**

\$20.00 FACTS fee is applied if you choose to pay the tuition in one payment.

\$50.00 FACTS fee is applied if you choose a monthly payment plan.

\*Please refer to your online FACTS account for your chosen tuition and fees due date. A late fee of \$50.00 will be applied to your account at the end of each month on all unpaid balances. A FACTS fee of \$30.00 will be assessed in the event of non-sufficient funds (NSF).

**MULTIPLE CHILD DISCOUNT** Tuition is assessed after the full rate is charged for the oldest child. A 10% discount is provided for the second sibling, a 25% discount for the third sibling and all subsequent. For siblings with scholarships, all scholarships will be applied to the full tuition. The sibling discount will then apply to the remaining balance.

**WITHDRAWALS** To withdraw a student, parent/legal guardian must notify the academy office in writing. There is a \$50 withdrawal fee that needs to be paid as well as all financial obligations owed to Christ Fellowship Academy in order to finalize the withdrawal and terminate your FACTS account. If your FACTS account remains open, you are responsible for all remaining tuition and fees. **All paid tuition and fees are non-refundable and non-transferable.** Once this process is complete, transcripts may be released.

**PROGRAM TRANSFER FEE** There is a \$50 fee for transferring during the school year between preschool programs. Please note that only one program transfer is allowed per school year.

### **EXTENDED SCHOOL DAY (ESD)**

**(Pre-school through 5<sup>th</sup> grade)**

Our Extended School Day (ESD) program is open from 7:00 a.m. to 8:00 a.m. and in the afternoon until 6:00 p.m. every day that school is in session. This service is provided to you at a monthly or hourly rate in addition to your tuition charges.

The monthly charges are based on 180 school days. Any full-days of ESD care when school is not in session are not included. Your account will be billed monthly beginning August 2022 and continuing until May 2023. No credit is given for days absent. Any changes in ESD billing must be made in writing to the Financial Office. Only future months will be changed; no retroactive credit adjustments will be made. You may only add/drop the monthly rate once during the school year. **If you use the ESD care and are not signed up for the monthly rate, you will be charged \$4.50 per hour for the time you use.** As always ESD care closes promptly at 6:00 p.m. A \$25.00 surcharge for every 15 minutes or any part thereof will be charged to your account should you sign your child out after 6:00 p.m. If a child is dropped off before 8:00 a.m. or remains after regular school dismissal time, they must be checked into ESD care.

**\*\*THERE IS NO ESD FOR HALF-DAY OR VPK ONLY STUDENTS\*\***

A \$25.00 surcharge for every 15 minutes or any part thereof will be charged to any Half-Day or VPK only student that is picked up after their dismissal time.

### **NON-SCHOOL DAY CARE (NSD)**

Students attending NSD care (Christmas Break, Spring Break, etc.) will be charged \$50.00 per day. There is no hourly rate for non-school day care.
